

Oregon Statewide Snapshot

July 1, 2023

Comagine Health continually tracks Oregon performance on a number of quality and resource use metrics. The table on the following pages provides a snapshot of Oregon's overall primary care clinic performance. The table shows Oregon's score for each measure compared to local and national benchmarks. It also includes information on the three-year trend for each measure.

For the local benchmark, Comagine calculates the Oregon Achievable Benchmark of Care (ABC), labeled Oregon's Best Benchmark. This benchmark provides a method to identify performance levels already being achieved by "best-in-class" primary care clinics within Oregon. "Best-in-class" Oregon clinic scores are calculated using the paired mean rate of the highest performing clinics providing care to at least 10 percent of the patient population.

The national benchmarks come from National Committee for Quality Assurance (NCQA) HEDIS[®] (Healthcare Effectiveness Data and Information Set). For each measure, the national mean and 90th percentile were calculated by weighting the 2021 Measure Year HEDIS[®] benchmarks for each line of business based on the proportion of each population (commercial, Medicaid and Medicare).
